





The SDGs supply a framework for companies to evaluate how they are performing against their ESG commitments.






Environmental Stewardship

It's more than simply a push for cleaner energy sources, but also transforming the way we think about fueling vehicles. Booster is at the forefront of delivering innovative solutions that align with sustainability goals and support the transition.



Mobile Fueling

One of Booster's standout contributions to the energy transition lies in its commitment to reducing the carbon footprint associated with traditional refueling practices.

Booster's approach to fueling is simple and straightforward. Instead of requiring customers to visit gas stations, we deliver a variety of traditional and alternative fuels directly to customer sites.

Mobile fueling not only saves time but also reduces traffic congestion and greenhouse gas emissions.

This approach aligns seamlessly with the move to alternative fuels and electric vehicles (EVs) by making them more accessible to customers.



Cleaner Energy

Booster actively promotes alternative fuels and electric vehicle charging solutions to customers who are interested.

When partnering with our customers to provide mobile fueling services, we talk with our customers about what a transition to cleaner energy sources could look like for their fleet, when they are ready.

Whether it's supplying electric vehicle charging infrastructure or offering fuel alternatives, Booster empowers its customers to make environmentally responsible choices that contribute to the reduction of greenhouse gas emissions.

Booster offers a range of sustainable fuels to lower emissions for existing internal combustion engine vehicles, including alternative fuels like renewable diesel.

Nearly all of Booster's fleet clients have switched to Renewable Diesel in markets where it is available. This sustainable alternative fuel offers up to 85% fewer lifecycle emissions than petroleum diesel.

In 2023, we had over 250+ customers using alternative fuels, including renewable diesel, hydrogen, and EV. Of those customers, we helped over 75+ customers transition from conventional diesel to RD in the past year.


Using Technology to Improve Sustainability

Our commitment to sustainability extends beyond just our services; it is deeply ingrained in our company's operations and the technology we use to deliver for our customers.

For our customers...

Our Booster Customer Portal allows our customers to see everything from service reporting to consumption amounts, and spending, empowering them to make better, faster decisions.

This platform allows us to schedule conventional and sustainable fuels to be delivered directly to fleets with a solution that is better for our customers, their communities, and the planet.



For our own fleet...

The Booster Smart Tankers utilize telematic technology to track and improve the sustainability of our own fleet.

- We monitor safe driving to help reduce negative driving behaviors like speeding, hard braking, aggressive driving, and abrupt acceleration, all of which negatively impact fuel economy.
- We track vehicle health because tankers with poor performance consume more fuel. Our smart tankers have fault code notifications alert to vehicle performance issues including tire pressure and idling.
- We use GPS-enabled routing to ensure we have the most efficient routes each night to reduce miles traveled and fuel consumed

Setting the Standards for Safe Fueling



Though our mission seeks to bring sustainable fueling solutions to fleets everywhere, we recognize that true sustainability must prioritize the safety and longevity of our teammates and the communities we serve.

With this recognition in mind, we've developed robust safety protocols to define how we operate. These protocols ensure that fueling is conducted safely and efficiently, minimizing the risk of accidents or spills. Additionally, our smart tanker technology ensures the fueling process is as efficient, effective, and safe as possible - the correct amount of fuel is dispensed at the right location with high-quality spill protection. We follow and often exceed, all requirements for onboard refueling vapor recovery (ORVR).

To safely fuel vehicles, our Service Professionals are required to obtain and maintain a CDL Class C permit, with hazmat and tanker endorsements.

We also have the following safe fueling measures in place to protect the environment and our customers:

Exceed safety expectations – All U.S. Department of Transportation, Environmental Protection Agency, and fire and air quality requirements for fuel transport, storage, and dispensation.

Adherence to highest requirements – Fully compliant with NFPA 30A, FMCSA, and the International Fire Code.

Exceed safety expectations – All U.S. Department of Transportation, Environmental Protection Agency, and fire and air quality requirements for fuel transport, storage, and dispensation.

End-to-end insurance – Comprehensive commercial auto and pollution insurance with enterprise-class liability coverage.

Spill prevention – Three-stage Perfect Boost spill prevention protocol with a zero-drip policy based on fire hazmat safety measures.

CARB Executive Order - Validation through policy executive order of Booster's high standards for emissions reduction as the benchmark for the industry.
 National Fire Protection Association (NFPA) requirements under NFPA-30A - Meets all requirements of the NFPA Flammable and Combustible Liquids Code.
 Federal Motor Carrier Safety Administration (FMCSA) and International Fire Code (IFC) - Meets all requirements for on-demand mobile fueling
 Advanced National Institute of Standards and Technology (NIST) certified - Meets federal DOT, EPA, Weights & Measures, and Air Resources standards.
 All of our drivers are qualified as SMITH System drivers - The SMITH System is the industry standard for defensive driving for commercial drivers.
 Every delivery vehicle is equipped with an automatic shutoff nozzle, and 30-gallon fuel-limit switch, and is overturn spill protection certified (NFPA 385).
 The Occupational Safety and Health Administration (OSHA) - Meet all Federal and State standards.

Our Compliance Standards

On-board Vapor Recovery (ORVR) – Technology-enabled compliance to all ORVR standards.
Eco-Nozzle – Reduces vapor emissions for every Boost, with technology-powered ORVR compliance, standard on every tanker.
Fusion-welded, pressure-tested tanks – Our tanks offer thermal protection sufficient to resist a pool fire for 100 minutes or a torch fire for 30 minutes (49 CFR 179.100-3, 179.100-18 & 179.18)
Features impact guards – Meets Federal Motor Vehicle Safety Standard No. 223 requirement (49 CFR 571.223).
Personal Protective Gear: Every service professional must wear safety gloves, sturdy shoes, eye protection, high visibility clothing, headlamps, and more.



Perfect Boost

Each service professional is trained, licensed, and fully certified to safely transport and deliver fuel.

"The Perfect Boost" is the process followed by our Service Professionals immediately before, during, and after the act of fueling a vehicle. This promotes safe, efficient, and consistent service delivery across all markets.



We are also proud partners with Women in Trucking (WIT) which is a non-profit organization with a mission to encourage the employment of women in the trucking industry.

Internal Mobility

At Booster, we care about growing and developing our teammates. We have a high internal mobility rate; as of today, over 25% of our Service Professionals have been promoted to higher-level positions and over 10% of corp employees have transitioned internally.

We achieve this through several internal training programs:

CDL Academy:

We have built an internal training program to provide a solution to the truck driver shortage and improve the lives of the people in the communities that we serve. We provide higher-paying jobs and full training for CDL licensing/endorsements for our Academy participants.

Leadership Skill Development:

We know that our leaders play a pivotal role in our success. For that reason, we have several different programs to develop our leaders at all levels of the organization including partnerships with well-known leadership training organizations like Lifelabs.

Booster has developed, and continues to refine, a comprehensive career architecture. This work provides employees with a clear and structured path for professional growth.



We have started creating more transparency and openly communicating our compensation structures. This means sharing salary ranges for different roles and levels as we hire new employees.





Booster has a qualified Board of Directors in place and maintains governance through two committees: Audit and Compensation. Each committee has a specific mandate to ensure merit fulfills the highest possible standards for equity, fairness, transparency, and ethics.

We have clearly outlined policies to protect against discrimination, harassment, and retaliation

All Booster employees are expected to avoid any conflict of interest when conducting their business dealings with customers, suppliers, partners, and vendors. This is to protect the interests — and the integrity of — our employees and our company.

Our most prominent suppliers — fuel refineries — include Chevron, Phillips 66, and other global energy providers that are required to certify the environmental impact of their products and operations.

Strict policies to protect against discrimination, harassment, and retaliation.

Booster's purchasing guidelines prefer and stimulate the use of renewable fuels (particularly renewable diesel) in our customer's markets. We seek to reduce the total carbon impact of fuels we buy and deliver, in order to drive measurable Scope 1 and 3 reductions for Booster and our customers.

An open-door policy to encourage honest and direct communication to resolve issues and concerns in an expeditious manner.

Our asset purchases, including tanker trucks and components, are reviewed for a range of sustainability and safety requirements, including clean idle tech, driver ergonomics, quiet operation, and more.

A whistleblower process that provides an alternative and anonymous method of reporting suspected compliance violations, unlawful or unethical behavior, or fraud.
